Independent Auditor's Report To the Rajdhani Unnayan Katripakkha (RAJUK)

Report on the Audit of the Financial Statements

Qualified Opinion

We have audited the financial statements of Rajdhani Unnayan Katripakkha ("the Entity" or "RAJUK"), which comprise the statement of financial position as at 30 June 2022, and the statement of profit or loss and other comprehensive income, statement of changes in equity and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, except for the matters described in the Basis for Qualified Opinion section of our report, the accompanying financial statements give a true and fair view of the financial position of the entities as at 30 June 2022, and of its financial performance and its cash flows for the year then ended in accordance with policy note B.

Basis for Qualified Opinion

RAJUK leases flats, land and other infrastructure to the public, and this lease require government registration through different sub registered office. As per section 53H Income Tax Ordinance 1984, the tax on property registration supposed to be paid by the developers. However in the case of the RAJUK, this property registration tax imposed on the public which is the noncompliance with the regulation. A huge amount of Advance Income Tax is deposited in the name of RAJUK from collection this amount from the public. But the entity didn't recognized this significant amount of advance income tax in their financial statement as asset. We attempted to quantify the amount by communicating with the different sub registered offices, but we were unable to do so due to their lack of cooperation. As a result, based on our audit procedures, we have concluded that the possible effects of these unaccounted amount on the financial statements could be material. Therefore, we have expressed a qualified opinion on this.

We conducted our audit in accordance with International Standards on Auditing (ISAs). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Entity in accordance with the ethical requirement that are relevant to our audit of the financial statements in Bangladesh, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of matter

1. We draw your attention to policy note no. C (ii) of the entity, depreciation of fixed assets should charge from the date of acquisition in compliance with the entity's policy and reporting regulation. Our opinion is not modified in respect of this matter.
2. We draw your attention to note 17.03, the company has only made a tax provision for the year 2021 and 2022. However, we have noted that the entity's tax files have been in various stages of trial since the assessment year 2000 and no provision has been made for this potential liability. Our opinion is not modified in respect of this matter.
3. We draw your attention to policy note no. C (ii), the entity should allocate the cost of these assets over their useful life or charge depreciation. Our opinion is not modified in respect of this matter.
4. We draw your attention to policy note C (vii), regarding the interest on FDR. Our opinion is not modified in respect of this matter.

Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Entity to cease to continue as a going concern.
- ▶ Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

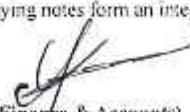

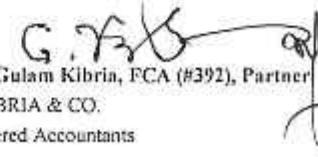

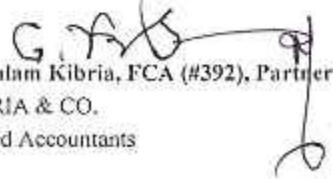

**NOTES TO THE FINANCIAL
STATEMENTS FOR THE YEAR
ENDED 30 JUNE 2022**

A. Background and Objectives:

Rajdhani Unnayan Kartripakkha (RAJUK) a service oriented statutory body under the ministry of Housing and public works, Govt. of Bangladesh was created as per provision of the town Improvement Act of 1953 (as amended up to June 1991). At present it's area of jurisdiction is 1528 sq. km. Rajuk is involved with the task of planning, development and development control for the area of its jurisdiction.

B. Basis of Preparation:

i) Basis of Accounting:

These financial statements have been prepared in accordance with Generally Accepted Accounting Principles (GAAP), and The Town Improvement Act' 1953 (as amended up to June 1991).

ii) Basis of Measurement:

These financial statements have been prepared on going concern basis under historical cost convention.

iii) Functional and Presentation Currency:

These financial statements are presented in BDT, which is the Authority's functional currency. All financial information presented in BDT has been rounded off to nearest Taka.

iv) Use of Estimates and Judgments:

The presentation of financial statement requires managements to make judgments, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates. Estimates and assumptions are reviewed on an on going basis.

C. Significant Accounting policies:

i) Recognition of Fixed Assets:

Property, Plant & Equipment are accounted for according to IAS 16 "Property, Plant & Equipment" at Historical cost less cumulative depreciation. The cost of self-constructed/installed assets includes the cost of materials, direct labor and any other costs directly attributable to bringing the assets to the working condition for its intended use and the cost of dismantling and removing the items and restoring the site on which they are located.

ii) Depreciation of Fixed Assets:

Depreciation has been charged on addition from the date of acquisition & revaluation date and no depreciation is provided on retirement/disposal of assets. Depreciation was computed using the diminishing balance method. The cost and accumulated depreciation of depreciable assets retired or otherwise disposed of are climate from the assets and accumulated depreciation:

As a government body, RAJUK follows the rules and policies set by the government. RAJUK maintains two types of funds, namely revenue fund and capital fund. With these funds, RAJUK develops various types of apartments, shops, and undertakes different projects for the betterment of the public at large. Although these investments have a definite useful life, RAJUK does not allocate the cost of these assets over their useful life or charge depreciation, as per past practice and the government system. The government has not yet come to a conclusion on how to adjust these types of projects and RAJUK continues to follow the same system.

iii) Fixed Deposit:

(a) This represents 402 numbers of FDRs made on different dates with different scheduled banks for the tenure of six month to one year. Total FDR includes the deposit of balance in different funds such as Capital Fund and Revenue Fund.

(b) Interests accrued on Fixed Deposits are not added with deposits i.e. the amount of Fixed Deposits shown on Balance Sheet is the amount of aggregate face value of those Fixed Deposits only.

iv) Employee Benefit Schemes:

The authority has constituted two un-recognized provident funds namely General Provident Fund and Contributory Provident Fund as per the rules of Govt. of Bangladesh. The authority makes contributions to provident fund as per rule.

v) Revenue Recognition:

Revenue is recognized as and when services are rendered,

vi) Debtors:

No provision against debts specifically considered irrecoverable has been made in the accounts.

vii) Interest Income:

FDR has been maintained separately by capital fund and revenue fund and requirement has been shown as fund wise income statement. Interests accrued on FDR are recognized on cash basis.

viii) Reporting Period:

The financial period of the Authority covers the activities from 01 July 2021 to 30 June 2022.

ix) General:

The figures in these accounts have been rounded off to the nearest Taka. Previous year's figures have been rearranged, wherever necessary, to conform to current year's presentation.
